COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Damage to Prop-1st Deg-Value Reduced Over \$1000

Minnesota Statute: 609.595.1(3), with reference to: 609.595.1

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 08/26/2015

Control #(ICR#): 15321676

Charge Description: That on or about 8/26/2015, in Minneapolis, in Hennepin County, Minnesota, EMMANUEL DESHAWN ARANDA intentionally caused damage to physical property belonging to the Hennepin County Sumner Library, without victim's consent and such damage reduced the value of the property by more than \$1,000 as measured by the cost of repair and/or replacement.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On August 26, 2015, at approximately 12:30 p.m., Minneapolis police were dispatched to the Sumner Library located at 611 Van White Memorial Boulevard north, Minneapolis, in Hennepin County, on a report from a witness M.A. who stated that EMAUEL DESHAWN ARANDA, DOB 08/23/1991, the defendant herein, had been sitting at a computer on the second floor where two rows of computers were sitting on tables and suddenly she heard loud crashing noises. She went to the second floor with security guard R.S. and both observed computer parts smashed on the floor and saw ARANDA with a computer in his arms which he then smashed on the floor. Hennepin County Security guard J.M. responded and located ARANDA at the bus stop on Olson Memorial Highway across the street. R.S. and J.M. apprehended ARANDA and arrested him without incident. In a post-Miranda recorded statement ARANDA told this affiant he became angry after he read something on the Facebook and so he smashed the computers on the floor. He said he has some anger issues and told the officer that it does not happen all the time. Five computers, screens and keyboards were smashed beyond repair and have a total value of approximately \$5,000. ARANDA was also then wanted on a Misdemeanor warrant for Fleeing and 4th Degree Intentional Damage to property and a Gross Misdemeanor warrant for Obstruction and 4th Degree Intentional Damage to property.
